Roommate with same gender, and within 3 years age difference, 3 beds to a room, pediatric admissions get "slower" in the summer time, breaks are a stressor for kids, tele-assessments in the schools, telemedicine clinics out of two outpatient hospitals, art therapy, rock-climbing wall, group therapy, family visits, very structured day, fence just built to allow for more play. Pscych-only facility, unable to take medically complex patients, can manage wheelchair bound patients, seizing patients or any patients with any "tubes" is also a "no," will take high-functioning autistic patients,
